I am glad to report that our organization continues to be one of the most active student organizations at the law school. We are actively building on the achievements of prior years. This summer, we were awarded the Federalist Society's Benjamin Franklin Award for Spring Breakout Chapter.

With over forty new dues-paying members, and a similar number of students helping to run the chapter, 2015-16 is off to a great start. This fall we organized 17 events including 8 speaking events, 4 faculty-student lunches (continuing and expanding the Faculty-Student Lunch Series begun last year), two receptions, and several other social and recruiting events.
